### Cash fund

### What is the purpose of this update?

This document tells you how Cash has performed and what fees were charged. The document will help you to compare the fund with other funds. UniSaver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

### Description of this fund

Cash invests fully in New Zealand cash. It's objective is to provide a return broadly in line with that of the S&P/NZX Bank Bills 90-Day Index after tax.

### What are the risks of investing?

#### Risk indicator for Cash



The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund's assets goes up and down. A higher risk generally means higher potential returns over time, but more ups and downs along the way.

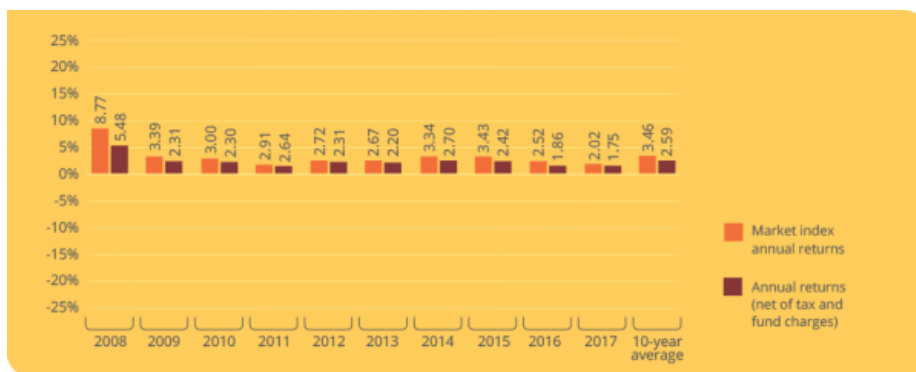
## How has the fund performed?

The benchmark for Cash is the S&P/NZX Bank Bills 90-Day Index. This index provides a measure of the cumulative increase in the market value of a portfolio of bank bills based on a daily roll over and purchase of a new bank bill of 90-day maturity.

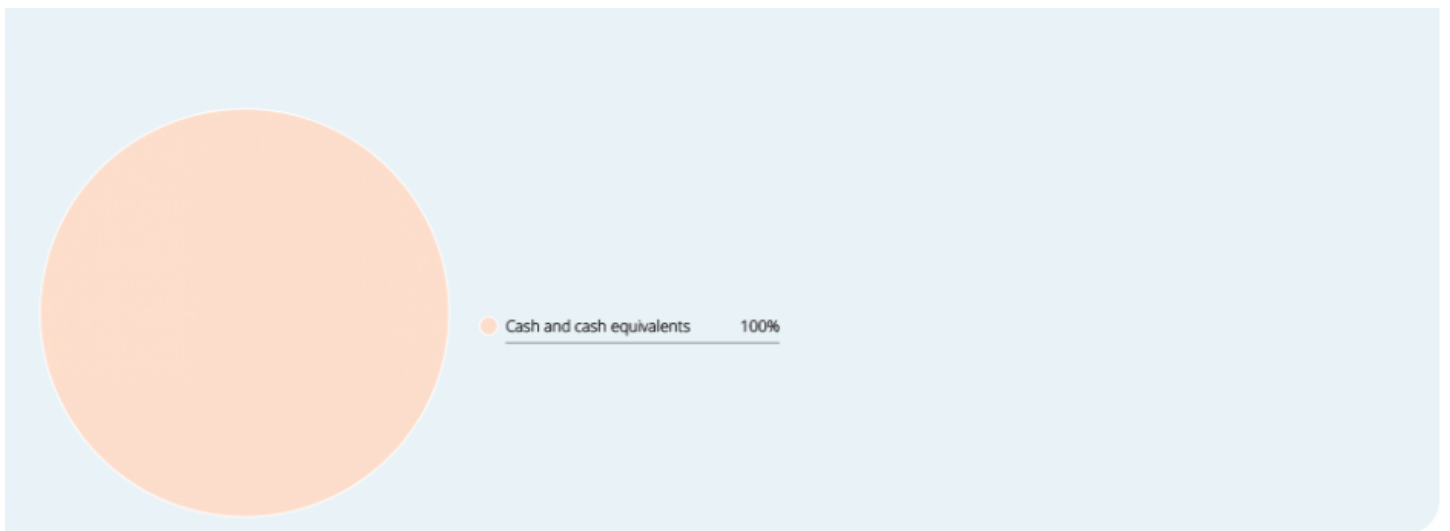
### Example of how this applies to an investor

Mary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$236.51 (that is 2.37% of her initial \$10,000). This gives Mary a total return after tax of \$174.97 for the year.
