

2019 UNISAVER NEW ZEALAND FUND UPDATE GROWTH

For the year ended 31 December 2019



This update was first made publicly available on 22 October 2020.

This is a replacement fund update. It replaces the 31 December 2019 Growth fund update first made publicly available on 27 March 2020. The total fund charges for the scheme year set out under the heading “What fees are investors charged?” have been corrected. The correct total fund charge is 0.75%, which replaced the previously disclosed total fund charge of 0.67%. As a consequence of that correction, the annual returns (after deductions for charges but before tax) stated in the table under the heading “How has the fund performed” have been recalculated and the fees example under the heading “Example of how this applies to an investor” has been adjusted to reflect the correct annual returns that applied to an investor for the scheme year ended 31 December 2019.

What is the purpose of this update?

This document tells you how Growth has performed and what fees were charged. The document will help you to compare the fund with other funds. UniSaver Limited prepared this update in accordance with the Financial Markets Conduct Act 2013. This information is not audited and may be updated.

Description of this fund

Growth invests predominantly in growth assets (Australasian and international shares, global listed property and global listed infrastructure) with a smaller percentage in income assets. Its principal objective is to achieve returns of 2.75% above inflation over rolling 10-year periods while keeping the risk of a member losing more than 20% after inflation in any one year reasonably small.

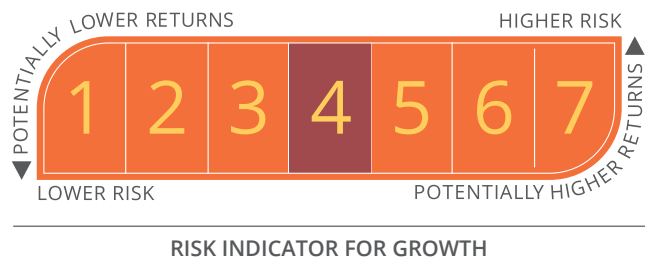
What are the risks of investing?

The risk indicator is rated from 1 (low) to 7 (high). The rating reflects how much the value of the fund’s assets goes up and down. A higher risk generally means higher potential returns over time but more ups and downs along the way.

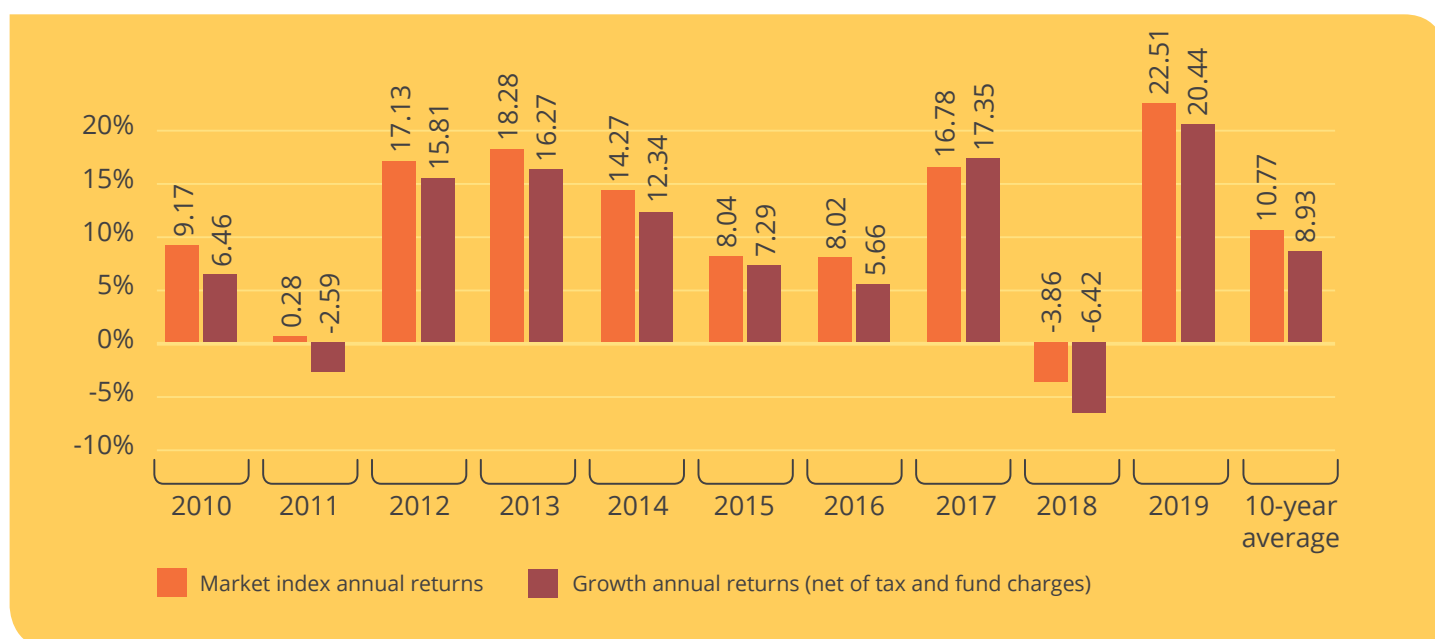
How has the fund performed?

The market index annual return is based on the returns of a composite index. The composite index is made up of the individual asset class benchmark indices used to measure the performance of each underlying fund/asset class into which the fund invests. Accordingly, the market index annual return for the fund is a composite return, calculated using the weighted average return of the benchmark indices used to measure the performance of the underlying funds/assets into which the fund invests. The weighting for each benchmark within the composite is equal to the strategic asset allocation weighting for that asset class. This market index return provides a relative measure of the fund's performance. The individual asset class benchmarks for global equities and global high yield changed during the year for consistency with changes made by the underlying fund manager to better reflect the relevant underlying funds' investment strategy and investable universe.

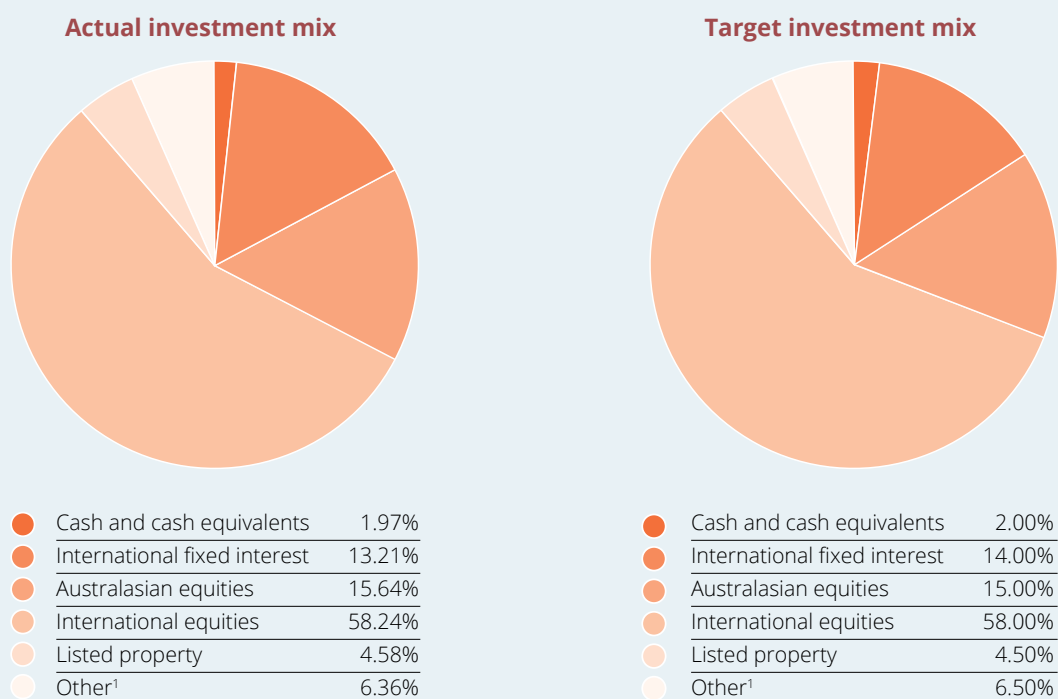

Example of how this applies to an investor

Mary had \$10,000 in the fund at the start of the year and did not make any further contributions. At the end of the year, Mary received a return after fund charges were deducted of \$2,151 (that is 21.51% of her initial \$10,000). This gives Mary a total return after tax of \$2,044 for the year.
